Reply from Go safe (28.3.23) Good morning Ms Davies ,Thank you for your email regarding speeding along Trecastle. I can confirm that GoSafe currently have an enforcement location along the A40 Trecastle. We do offer Community Speed Watch. Community Speed Watch is a group of volunteers who stand roadside and monitor the speeds. Th results are then submitted online & anyone over the speeding threshold is sent a warning letter reminding them of the law. Would you or some of the residents be interested? Kind regards Gemma, GoSafe Edwin suggested we do a speed watch, The Chair and Janice volunteered to help. Clerk to email and accept offer.

7. Highways update:

10. Correspondence:

- a. (29.3.23) On **17th Sept 2023** most 30mph limits will change to 20mph in **Wales** as the [new national limit](#). This is a first for the UK. [20's Plenty for Us](#) is assisting anyone who wants to welcome this change, so that we can all help to make Welsh streets fair again. Our [web pages](#) can help keep you informed and inspired.

20mph replaces 30mph, unless a road is deliberately exempted and signed at 30mph. [Exceptions guidance](#) says that streets where there is demand, or could be, for vulnerable road users to mix with motor traffic should be included, even trunk A roads. Settlements may find buffer zones - eg where speeds reduce from 60mph to 40mph or 30mph - useful.

[New research](#) found lower driving speeds, increased walking and cycling levels and minimal impact on journey times in the Welsh places piloting 20mph.

Community Councils can request resources - such as a free pack of stickers in Welsh and English or a free online presentation from wales@20splenty.org Over 60 have already done so. Has yours?

In June 2023 we will carry out a Forest Stewardship Council® (FSC®) & The Programme for the Endorsement of Forest Certification (PEFC™) audit of forest management by Natural Resources Wales in the United Kingdom. They will be assessed against the requirements of the UK Woodland Assurance Standard (UKWAS) - V 4.0 (2018) ; FSC-STD-GBR-03-2017 V 1-0 EN.

g. Anwen Price (14.4.23) - I am writing to express my overwhelming objection to the plans to create an energy park on Nant Mithil in Radnorshire and to further install an overhead electricity distribution network via 60 miles of steel pylons from this proposed energy park.

The need to embrace renewable energy and to have energy security in Wales is recognised by all, particularly after the impact high energy costs have had this last winter on households and businesses.

However, I feel strongly that using steel pylons is **not** the answer. These pylons will be very unsightly, may well have health implications for people living near them, will result in the loss of fertile agricultural land and will drastically affect the number of visitors to an area where tourism is fundamental.

Numerous community meetings have been held across the county and the **overwhelming** feeling is that local residents **do not** want these plans to go ahead. Surely windfarms would be better located in the sea off the British Isles where they would not blight the landscape and have a devastating effect on the Welsh economy, tourism and agriculture.

The Welsh landscape has a plethora of benefits for the people of Wales and beyond. It has health, economic, historical, and cultural values which should be maintained and protected. People from all over the world visit Wales for the experience of being absorbed in well-managed picturesque landscapes, and this in turn ensures a thriving tourism economy which is essential for rural communities the length and breadth of Wales. Tourism is worth £6.2 billion to the Welsh economy, 13% of the total economy, and in mid-Wales 13% of employment is in tourism which demonstrates the reliance this area has on this important industry. Furthermore, people who have been brought up here or choose to live here and make Wales their home, also embrace the very same benefits as those who holiday with us.

To reiterate - **we do not want this project to go ahead in beautiful mid Wales** and we certainly do not want these ugly pylons to be placed in our areas.

We are totally opposed to this project and strongly believe that Green GEN Cymru must revisit its plans and look to locate wind turbines in the sea.

I would urge you to support the feelings of the majority of local residents and oppose, in any way possible, these unfortunate and devastating plans. I look forward to hearing from you.
